## PRESS RELEASE BY HCA

1. Vide order dated: 23.03.2017 the Hon'ble High Court was pleased to appoint a Committee of Administrators consisting of retired Judge of Hon'ble Supreme Court i.e. Justice Anil R Dhawe and retired Judge of Hon'ble High Court i.e. Justice G.V.Seetapathy. The Hon'ble High Court has specifically stated that the Committee of Administrator shall hold office only for the duration of IPL 2017 Cricket season, and till the Justice R.M Lodha Committee recommendations are implemented.
2. In their report dated 26.09.2017, the Committee of Administrators stated that, while the task entrusted to them has been substantially accomplished, what remains to be done by the HCA is to consider and approved the revised /amended byelaws, wherein all the recommendations of the Justice R.M.Lodha Committee, as approved by the Hon'ble Supreme Court, are incorporated with the approval of the Members in a special general body meeting; thereafter, send the same to the District Registrar of Societies for its due incorporation.
3. Vide order dated: 16.10.2017 the Hon'ble High Court stated that as the Committee of Administrators have substantially done their work and only the exercise off revise/amended byelaws being approved by the Members of the HCA in a special general body meeting, incorporating all the recommendations of the Justice R.M.Lodha Committee; and, thereafter, to have the amended byelaws duly incorporated and registered with the
