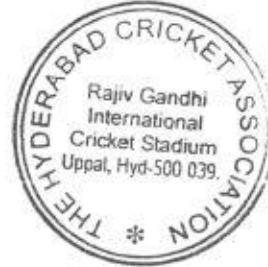

II	B. One Councillor nominated from Accountant General of State. a)The nominee of Accountant General shall provide monitoring in financial and audit of the association.
III	C) One Councillor nominated from Players Association (Male). a) The Player nominee shall provide monitoring on the structure development and welfare of Men's Cricket.
IV	D)One Councillor nominated from Players Association (Female). a)The Player nominee shall provide monitoring on the structure development and welfare of Women's Cricket
V	There shall be no proxy voting by any member in the Annual General Meeting, Special General Meeting or wherever it requires or occurs.
VI	a)The Association shall grant membership to International Players Men and Women who have represented the country in International Matches conducted by BCCI or ICC. b)Provided however, the Apex Council shall complete the process of enrollment of such players within a period of 30 days from the date of receipt of the prescribed form, after which the said player shall automatically be deemed to have been enrolled a Member of Hyderabad Cricket Association.

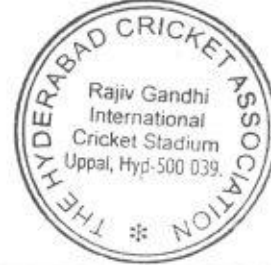

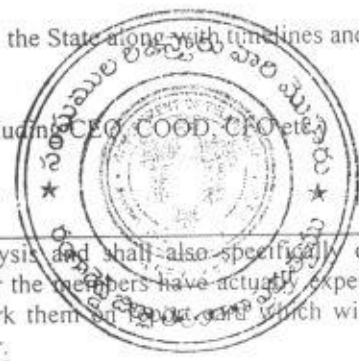

VII	<p>No Member or any representative of the club shall not be entitled, eligible to hold any post in the Apex Council or the Association if he or she</p> <ol style="list-style-type: none"> Is not a citizen of India Has attained the age of 70 years Is declared to be insolvent, or of unsound mind; Is a Minister or Government Servant Holds any office or post in a sports or athletic association or federation in India apart from cricket, Has been an Office Bearer /Councillor of the HCA for a maximum period of 9 years The term of Office Bearers and Councillor shall be for a period of 3 years from the date of election. No Office Bearer or Councillor shall contest the election for any post of the Apex Council immediately subsequent to his tenure. <p>Chargesheeted by any court in criminal offence</p>
VIII	<p>The Apex Council shall create and keep posted up to date a Website with the information regarding activities of HCA its members, byelaws, Accounts balance sheet and details of the players and the cricket matches of each season.</p> <ol style="list-style-type: none"> The Constitution, Memorandum of Association and Rules & Regulations, Bye-laws and Office Orders and directions that govern the functioning of the Association, its Committees, the Ombudsman and the Ethics Officer. The list of Members of the Association as well as those who are defaulters. The annual accounts & audited balance sheets and head-wise income and expenditure details. Details of male, female and differently abled players representing the State at all age of groups with their names, ages and detailed playing statistics. Advertisements and invitations for tenders when the Association is seeking supply of any goods or services (exceeding a minimum prescribed value), or notices regarding recruitment, as also the detailed process for awarding such contracts or making such recruitments. Details of all goals and milestones for developing cricket in the State along with timelines and the measures undertaken to achieve each of them. Details of all office bearers and other managerial staff (including CEO, COOD, CFO etc) Details of directives from the BCCI and their compliances.
IX	<p>AUDITOR: The auditor shall transact with financial analysis and shall also specifically carry performance audit (compliance report) to determine whether the members have actually expended their grants towards the development of the game and mark them on report and which will be utilized to determine the dues they deserve for following year.</p>

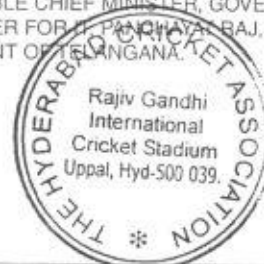

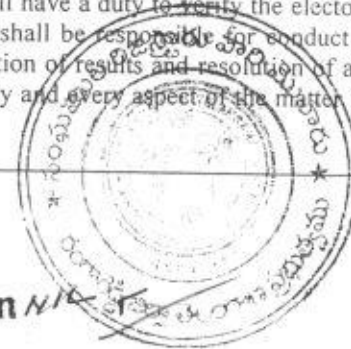

X	The Apex Council shall a) Award Contracts and b) invite tenders for supply of all types of goods and services.
XI	The HCA shall construct stadiums in each district of the state.
XII	Conflict of Interest: No person member or individual, employed therein or connected thereof to the HCA, and further the Office Bearer, Councillor, Player, employees, administrator, team official, umpire or any other person connected to the HCA its members, contractors, workers, agents shall not have any interest in direct or indirect conflict with the HCA players, members or the officials in any traceable or intraceable manner.
XIII	OMBUDSMEN: Shall be a Former Chief Justice of any High court. His term shall be for a period of one year. He shall be appointed by the General Body. The Ombudsmen shall on reference by the Apex Council or on a complaint by a member / franchise / zone / player's association / player / team official / administrator shall investigate and resolve any dispute between the HCA and any other above entities or among themselves by following due principles of natural justice, production of evidence and fair hearing. He also shall redress any grievance or complaint by members of the public if they concern ticketing, access and facilities at stadia and lack of transparency in the award of contracts for goods and services.
XIV	ETHICS OFFICER: Shall monitor the principles of Conflict of Interest along with Code of Behaviour of HCA. The said power also should include laying down of additional guidelines or byelaws on his oral ethics, initiation or investigation or adjudicatory proceedings and award of warnings, fines, reprimands, suspensions or other action as may be recommended to HCA
XV	ELECTORAL OFFICER: The Apex Council shall appoint a former or present Election Commissioner of the state to be its Electoral Officer, as prescribed hereinafter. The said officer should conduct and supervise the entire process of election shall have a duty to verify the electoral rolls identify appropriate representatives of the full members shall be responsible for conduct of elections from the date of filing of nomination, to the declaration of results and resolution of any dispute and objections during the elections. His decision on any and every aspect of the matter for election shall be final and conclusive.
