

MINUTES OF THE FIFTH APEX COUNCIL MEETING OF THE HYDERABAD CRICKET ASSOCIATION HELD ON MONDAY THE SIXTEENTH DAY OF MARCH, 2020 AT 2:00 PM AT HCA REGISTERED OFFICE, RAJIV GANDHI INTERNATIONAL CRICKET STADIUM, UPPAL, HYDERABAD.

Leave of absence is granted to Mr.Santosh V Daware, CAG Nominee to this Fifth Apex Council Meeting.

The Hon. Secretary R.Vijayanand welcomed all the members of the Apex council to the Fifth Apex Council Meeting and informed that they are not taking up the item no. 4 & 5 of the Agenda i.e., Tenders for ensuing IPL Matches due to the postponement of the IPL -13 Season by BCCI and postponement of fixing a date for conducting the AGM due to Novel Corona Virus (COVID-19).

The Hon. Secretary R.Vijayanand with a profound grief, requested the Members to observe two minutes silence as a mark of respect to the departed soul of Late Mr.E.Gopal and Late Mr.Fayazuddin who expired on 11.03.2020 after serving the association for a long period.

The Members responded and observed two minutes silence as a mark of respect to the departed souls.

The Secretary Mr.R.Vijayanand requested the President Mr. Mohammad Azharuddin to preside over the meeting.

The President Mr. Mohammad Azharuddin took up the agenda as follows.

**Item No.1: Confirmation of Minutes**

All the members of Apex Council unanimously confirmed the minutes of the 4<sup>th</sup> Apex Council meeting held on 02.02.2020 at Registered Office of HCA, RGICS, Uppal, Hyderabad.

**Item No.2 : Points arising out of minutes of the fourth apex council meeting:**

Page No.2:


Mr. John Manoj pointed out that there is a small typographical mistake in the para no.3 page 2 it is mentioned as “that Shalimar Cricket XI it should **complete** under Ranga Reddy Jurisdiction” instead of mentioning it should **come** under Ranga Reddy Jurisdiction and in same para it is typed as Shalimar Cricket IX due to oversight and needs to be changed as Shalimar XI.

Mr. Parth Satwalekar pointed out that in page no.2 last but one para, I did not enquire about the stadium insurance but I enquired about the insurance to club members and the same needs to be corrected and the same is changed to insurance to club members.

Mr. John Manoj, Vice President stated that as we have one month time it is better to call for tenders for fire-fighting system.

Mr. Surender Kumar Agarwal, Treasurer dissented for calling tenders and he suggested that as the time is less we have to go for Expression of Interest for fire-fighting system.

Mr. Naresh Sharma, Joint Secretary also opined to call for tenders for fire-fighting system. After discussions and deliberations the apex members resolved to immediately call for tenders for fire-fighting system by appointing a consultant as per the norms.



Mr.R.Vijayanand, Secretary informed that we could not felicitate the U-16 boys team and Under-23 Women team as mentioned in the minutes of 4<sup>th</sup> apex council meeting at page no. 3, para 3 and the same is postponed to the Formation Day of Hyderabad Cricket Association i.e., April 14, 2020.

Mr.John Manoj, Vice President stated that as the Incharge CEO Mr.V.Venkateswara Rao has given his resignation letter with three months notice and the same ends by 20.04.2020, we need to release an advertisement immediately for the post of C.E.O and appoint a new C.E.O. as per Justice Lodha Recommendations and also for smooth functioning of day to day affairs of HCA.

Mr.John Manoj, Vice President enquired with the Incharge CEO Mr.V.Venkateswara Rao about the accounts for the period of 2017-18 and 2018-19 and informed that after submission of Utilization Certificate the BCCI had released an amount of Rs.10,00,00,000/- (Rupees Ten Crores Only) to the Hyderabad Cricket Association and the Board i.e., BCCI further informed that they will release pending funds after submission of audited accounts for the year 2017-18 & 2018-19.

Mr.V.Venkateswara Rao, Incharge CEO informed the members that M/s. Venugopal & Chenoy Statutory auditors had completed the audit for the year 2017-18 and he had to issue vetted financials and submit the report and the same needs to be adopted in the AGM. After adoption of 2017-18 accounts in AGM only he will take up the audit for the year 2018-19 and it may not be possible to complete the same before he leaves the Office. He further clarified to the members that the Statutory Audit for the year 2018-19 has not yet commenced. He further informed that M/s. Venugopal & Chenoy, CAs have submitted their resignation for the year 2017-18.

Mr. Surender Kumar Agarwal, Treasurer informed that there is no problem with internal auditors. And further informed that Mr.Vijayanand, Secretary also talked to M/s. Venugopal Chenoy, Statutory Auditors and they are willing to continue as HCA Auditors. He further informed that for the first time BCCI has released the amount without deputing their team of officials for cross checking the accounts. Mr.V.Venkateswara Rao, Incharge CEO informed that as the earlier team of



officials has given good report to the BCCI in the month of September, 2019, BCCI has relied upon their report and released the amounts to HCA.

Mr. John Manoj pointed out that there is a typographical error its Abrar and not Abrah.

Page No.11 Last Paragraph

Mr. R. Vijayanand, Secretary stated that I have mentioned Rs.1,57,000/- and it is mentioned as Rs.57,000/- towards medical reimbursement to Mr. Yadagiri, Ex-Treasurer and needs to be corrected as Rs.1,57,000/-.

Mr. Surender Kumar Agarwal stated that it will become very difficult to reimburse the amount towards the medical bills of the club secretaries and suggested to get insurance to them at the earliest.

Mr. Parth Satwalekar, Men Players nominee sought clarification from which amounts they are reimbursing the medical bills and insurance to the club secretaries.

Mr. John Manoj, Vice President clarified that the reimbursement to the Club Secretaries towards medical bills and insurance to the club secretaries is paid from the HCA earned amounts and not from the fund granted by the BCCI. He further informed to ensure that medical bills are submitted by the concerned secretaries towards their reimbursement.

Mr. V. Venkateswara Rao, Incharge CEO informed that this season they have reimbursed to Mr. Ganesh Pai an amount of Rs. 3,00,000/- and we are in receipt of the bills amounting to Rs. 8,00,000/- and to Mr. Baig we have released an amount of Rs. 3,00,000/- towards medical reimbursement but received bills for an amount of Rs. 90,000/- only and to Dawood Ali Khan, Apex Council has approved an amount of Rs. 2,00,000/- towards medical reimbursement and we have released Rs. 49,518/- as we received Bills to that extent and we have not yet released the amount to Mr. Yadagiri, Ex-Treasurer towards his medical reimbursement.



Mr. John Manoj, Vice President stated to call for tenders for the Multi-level Parking so we can claim from BCCI towards Infrastructure.

Mr. R. Vijayanand, Secretary advised to install Solar Power Plant on the multi-level parking.

Mr. Parth Satwalekar, Men's Nominee suggested to install the solar power Plant in the stadium then multi-level parking like in Bangaluru Stadium as the solar power plant requires larger space. And he further stated not to merge multi-level parking and solar power plant.

Mr. R. Vijayanand, Secretary and Mr. Naresh Sharma, Joint Secretary clarified that it is a good idea but our stadium does not have the roof tops where we can install the solar power plant.


Mr. Surender Kumar Agarwal informed that on the Formation Day of Hyderabad Cricket Association we will announce the Cricket Activity i.e., on April 14, 2020.

Ms. Subhadrasuri requested to clearly clarify about the insurance to the club secretaries.

Mr. Surender Kumar Agarwal, Treasurer clarified by stating that from HCA earned funds, HCA will provide medical insurance to the Club Secretaries by taking insurance policy for a sum of Rs.3,00,000/- to each member and the same will be renewed every year.

Mr. Naresh Sharma, Joint Secretary requested to get the insurance to the club secretaries at the earliest.

Mr. John Manoj, Vice President stated that during 2014 we made correspondence to Mr. Kalvakuntla Taraka Rama Rao (Mr. KTR), Hon'ble Minister for M.A.&U.D., Industries and IT&C requesting that an amount of Rs.25,00,000/- per annum will be paid to IALA towards property tax and he kindly considered and agreed for the



same and from then we paid an amount of Rs.25,00,000/- per annum and requested to check the correspondence in HCA records and get it regularized.

Mr.V.Venkateswara Rao, Incharge CEO informed that we are paying Rs.25,00,000/- by 31<sup>st</sup> March every year for the last 3-4 years as per the understanding with Mr.KTR but as per the records of IALA they are charging around Rs.2,00,00,000/- (Rupees Two Crores Only) per annum and adding 2% interest and updating online and now claiming around Rs.30,00,00,000/- towards arrears and the same needs to be dissolved at the Chairman level.

Page No.13:

Mr.John Manoj, Vice President stated that we have appointed Mr. Riaz Qureshi to get the feedback of Nizamabad Cricket Association to start the works like water works, get the ground prepared and cricket activity should start there at Nizamabad and we are going to visit Nizamabad Cricket Association at the earliest and inform the updates to the Apex Council Members.

Thus the minutes of fourth apex council meeting dated 02.02.2020 are confirmed.

Mr.R.Vijayanand, Secretary informed that we are celebrating Hyderabad Cricket Association Formation Day on 14.04.2020 at RGICS, Uppal. He further informed that we are releasing the payments to all the coaches and support staff for the year 2019-20. Details of payments are enclosed herewith as Annexure-I.

Item No. 3: Accounts for the month of January and February, 2020.

Apex Council approved the accounts.

Mr.John Manoj stated that we have to pay the staff bonus and Mr.V.Venkateswara Rao, Incharge CEO stated that we have to pay OT also and the employees have given a representation for payment of Bonus and OT. He further informed that for the first time the BCCI has released Rs.30 crores for the financial year 2019-20 when compared to past three (3) years.

Mr.V.Venkateswara Rao, Incharge CEO informed that for property insurance i.e., stadium insurance we have received quotations in the month of February, 2020 and



New India Assurance Co. Ltd has quoted the lowest premium at an amount of Rs.6,09,416/- and we have released the payment on 27.02.2020. After two days, the Deputy Manager of M/s. New India Assurance Co. Ltd represented that from 1<sup>st</sup> January, 2020 the rates have been differentiated as indoor and outdoor and due to oversight they have quoted the indoor rate and at the outdoor rate premium around comes to Rs.20,00,000/- and requesting either to pay the balance amount of 14,00,000/- or to accept refund. They are ready to refund premium paid by us in full.

Mr.John Manoj, Vice President opined to check the previous insurances to get an idea on the amounts quoted and then to proceed further.

Mr.Surender Kumar Agarwal, Treasurer stated to ensure refund and then go for the lowest quoted after collecting fresh quotations.



Mr.Surender Kumar Agarwal, Treasurer informed to appoint Cheque Signatories as V.Venkateswara Rao, Incharge CEO has submitted his resignation.

The Apex Council temporarily authorized Mr.SPBL Varaprasad, Accountant and Mr.M.Narayana, OSD as the cheque Signatories until the New CEO is appointed. This will come into force from next working day of relieving In-charge CEO.

Mr.V.Venkateswara Rao, Incharge CEO has clarified about insurance claim of canopy. Insurance claim is linked to replacement of Canopy and making payment. Then only insurance claim will be settled by National Insurance Company.

Mr.Surender Kumar Agarwal, Treasurer stated that we are not finding most of the files and opined to file police complaint for missing files. Mr.V.Venkateswara Rao stated that the earlier CFO has handed over three almarahs and we may find the files in those almarahs.

Mr.Azharuddin, President stated that the groundmen are using the heavy covers and when the covers are on line they are going on spikes whereby causing holes to the covers and suggested to tell them to go with rubbers. He further suggested to purchase 2 Land Movers and Rollers and covers at Gymkhana.



Mr. John Manoj, Vice President enquired about the plantation in the stadium.

Mr. R. Vijayanand, Secretary informed that his friend has sponsored 8 lakhs worth plants to stadium and it has costed Rs.80,000/- for planting the plants in the stadium towards labour charges. All the members appreciated for the work done by Mr. R. Vijayanand, Secretary for planting all the trees and plants in the stadium. Further he stated that an amount of Rs.75,000/- was incurred for the HCA Logo at Gate No.1 and Rs.1,75,000/- towards labour charges at Gate No.1.

Mr. V. Venkateswara Rao, Incharge CEO informed that M/s. Swamy Associates has given service towards service tax issues closing and have raised their bill for an amount of Rs.4,00,000/- + GST and Mr. Surender Kumar Agarwal stated to negotiate with M/s. Swamy Associates.

**Item No.6: Any other matter:**

Smt P. Anuradha, Councillor suggested to name one of the dressing rooms of the stadium as P. Krishna Murthy, Former Indian Test Wicket Keeper and during Mr. Shivalal Yadav and Mr. Yadagiri tenure there was a proposal to name one of the places in the stadium as Mr. P. Krishna Murthy.

Ms. Subhadra Suri suggested the naming of women cricket players in one of the places of the stadium.

Mr. R. Vijayanand, Secretary stated the same will be taken up in the AGM and after approval from AGM the same will be named in their name.

Mr. Surender Kumar Agarwal, Treasurer stated that Mr. Mukesh Kumar, Curator; Mrs. Vishnupriya, Stenographer cum Office Assistant; Mr. Md. Najeem, Attender and Mr. Dawood, Attender have given representations for enhancement in their salaries and the same is considered by the Members of the Apex Council. Mr. Mohammad Azharuddin and Mr. Surender Kumar Agarwal stated to enhance their salaries and Mr. Vijayanand, Secretary informed that in the month of April increments will be given to the staff and at the same time their salaries will be enhanced taking this into consideration.






Mr. John Manoj stated that after convening General Body Meeting at the BCCI, we hope BCCI will release Rs.30 crores to each of the State Associations.

Mr. V. Venkateswara Rao, Incharge CEO suggested to hire a Bank Locker to keep 13 tulas gold coins having with us. It is resolved to hire a Bank Locker at Canara Bank, Dilsukhnagar Branch and authorize the same with two signatories who sign the cheques to operate the Bank locker.

Mr. R. Vijayanand, Secretary stated that we will pay an amount of Rs.3,00,000/- towards exgratia to the deceased E. Gopal family members as a Special Case (i.e., his three daughters Rs.1,00,000/- each) considering his services rendered to the HCA.

The meeting is concluded with vote of thanks by Mr. K. John Manoj, Vice President to the Chair and the members of Apex Council.

Mr. John Manoj, stated that people who are working from so many years are getting less salary than those who have joined later. He further stated that all the employees should be justified as per their qualifications, designations and experience.

Mr. Path Satwalekar, Men's nominee enquired about the CPAH.

Mr. R. Vijayanand, Secretary informed that everything is ready and we will appoint an electoral officer within 15 days for conducting elections of CPAH.

Mr. V. Venkateswara Rao, Incharge CEO informed that we have paid an amount of Rs. 25,000/- each towards funeral expenses of Mr. E. Gopal and Mr. Faizuddin.

Mr. Parth Satwalekar stated that after the grant of amounts by BCCI to HCA, you stated you will start players' pension and as the BCCI has released a sum of Rs. 10 crores now, I request you to implement the pension scheme to the previous players and also clear pending payments to the coaches, support staff etc.

Mr. Surender Kumar Agarwal stated that we will release all the other payments only after the BCCI releases major amounts like Rs. 30 to 40 crores.

Mr. John Manoj, Vice President stated that we are in receipt of Rs. 10.80 crores recently from the BCCI and we have already spent an amount of Rs. 4.90 crores towards Service Tax. Balance fund of Rs. 5.90 cr. is required to pay IGST (1.80 cr.), Professional fee to Men Selectors, Coaches and other support staff (2.20 cr.), Professional fee to Women Selectors, Coaches and Support staff (0.65 cr.), Property tax to IALA (0.25 cr.), Air Travel & Hotel Bills (0.60 cr.) and other expenses like Transportation of Players, Salaries, Security, House Keeping etc (0.40 cr.) He further stated that when he was secretary he paid pensions and later on after their term is over the pensions were stopped and to overcome this we should deposit a consolidated amount in the bank and the interest earned on it should be paid towards the players pension. He further stated that Mr. Mohammad Azharuddin, President has requested the BCCI President to release an amount of Rs. 140 crores to HCA and even if the BCCI releases 40 to 50 crores to HCA a some amount should be fixed in the Bank and the interest earned should be paid towards pension to the players and the same should be continued even after our term is completed.
